APPORTIONMENT OF PENNSYLVANIA INTO CONGRESSIONAL DISTRICTS

(Act of the General Assembly approved June 27, 1931, P. L. 1416).

Section 1. Be it enacted, &c., That for the section 1. Be it enacted, &c., That for the purpose of electing representatives of the people of Pennsylvania to serve in the House of Representatives in the Congress of the United States, this State shall be divided into thirty-four districts, as follows:

The first district shall consist of the first, second, third, fourth, fifth, sixth, twenty-sixth, thirty-ninth, and forty-eighth wards of the city of Philadelphia, and will have one Congressman.

The second district shall consist of the seventh, eighth, ninth, tenth, twenty-fourth, twenty-seventh, thirtieth, thirty-sixth, and forty-fourth wards of the city of Philadelphia, and will have one Congressman.

The third district shall consist of the eleventh, twelfth, thirteenth, fourteenth, sixteenth, seventeenth, eighteenth, nineteenth, twentieth, teenth, eighteenth, nineteenth, twentieth, twenty-fifth, thirty-first, thirty-seventh, and forty-fifth wards of the city of Philadelphia, and will have one Congressman.

The fourth district shall consist of the fifteenth, twenty-eighth, twenty-ninth, thirty-second, thirty-eighth, and forty-seventh wards of the city of Philadelphia, and will have one Congressman.

The fifth district shall consist of the twenty-third, thirty-third, thirty-fifth, forty-first, and forty-third wards of the city of Philadelphia, and will have one Congressman.

The sixth district shall consist of the thirtyfourth, fortieth, and forty-sixth wards of the city of Philadelphia, and will have one Congressman.

The seventh district shall consist of the twenty-first twenty-second, and forty-second wards of the city of Philadelphia, and will have one Congressman.

The eighth district shall consist of the county of Delaware.

The ninth district shall consist of the counties of Bucks and Lehigh.

The tenth district shall consist of the coun-

ties of Lancaster and Chester.

The eleventh district shall consist of the county of Lackawanna.

The twelfth district shall consist of the

county of Luzerne.

The thirteenth district shall consist of the counties of Schuylkill and Northumberland.

The fourteenth district shall consist of the county of Berks.

The fifteenth district shall consist of the unties of Bradford, Pike, Susquehanna, counties of Bradford, Pike, Susquehanna, Wayne, Columbia, Montour, Sullivan, and Wy-

oming.

The sixteenth district shall consist of the counties of Clinton, Lycoming, Potter, Tioga, McKean, and Cameron.

The seventeenth district shall consist of the county of Montgomery.

The eighteenth district shall consist of the

counties of Fulton, Huntingdon, Juniata, Mifflin, Perry, Snyder, Bedford, and Union.

The nineteenth district shall consist of the counties of Cumberland, Dauphin, and Lebanon.

The twentieth district shall consist of the counties of Warren. Mercer, Venango, Forest, Clarion, and Elk.

The twenty-first district shall consist of the

counties of Northampton, Carbon, and Monroe. The twenty-second district shall consist of the counties of Adams, York, and Franklin. The twenty-third district shall consist of the

counties of Clearfield, Centre, and Blair.
The twenty-fourth district shall consist of

the counties of Fayette and Somerset.
The twenty-fifth district shall consist of the counties of Greene and Washington.

The twenty-sixth district shall consist of the counties of Beaver, Butler, and Lawrence.

The twenty-seventh district shall consist of the counties of Armstrong, Indiana, Jefferson, and Cambria.

The twenty-eighth district shall consist of the county of Westmoreland.

The twenty-ninth district shall consist of the counties of Crawford and Erie.

The thirtieth district shall consist of the twenty-first, twenty-second, twenty-third, twenty-fourth, twenty-fifth, twenty-sixth, and twenty-seventh wards of the city of Pittsburgh, and all the boroughs and townships, lying north of the Ohio and Allegheny rivers, not included in the thirty-first district, in the county of Allegheny.

The thirty-first district shall consist of all the boroughs and townships lying between the Allegheny and Monongahela rivers, and the bor-oughs of Springdale, Cheswick, Brackenridge, Allegheny and Mononganeta rivers, and the horoughs of Springdale, Cheswick, Brackenridge, Tarentum, the townships of Harrison, Fawn, East Deer, Frazer, and Springdale, and the city of McKeesport, in the county of Allegheny.

The thirty-second district shall consist of the first, second, third, fourth, fifth, sixth, ninth, tenth, eleventh and fifteenth wards of the city of Pittsburgh in the county of Alle-

The thirty-third district shall consist of the seventh, eighth, twelfth, thirteenth, fourteenth, sixteenth, seventeenth, eighteenth, nineteenth, twentieth, and twenty-eighth wards of the city of Pittsburgh, in the county of Allegheny.

The thirty-fourth district shall consist of the twenty-ninth, thirtieth, thirty-first, and thirty-second wards of the city of Pittsburgh, the cities of Clairton and Duquesne, and all the boroughs and townships lying south of the boroughs and townships lying south of the Ohio and Monongahela rivers, in the county of Allegheny.

Section 2. The nomination and election of members of the House of Representatives of the United States, which the qualified electors of any county, or of any part of a county, are entitled to elect of themselves unconnected with any other county or district, shall be made held, and conducted, and the return of votes cast at primary and general elections for the nomination and election of such members shall be made, computed, canvassed, and certified, as now or hereafter may be provided by law.

Section 3. In all congressional districts com-Section 3. In all congressional districts composed of two or more counties or parts of two or more counties, or of one or more counties and a part or parts of one or more counties, the county commissioners of each of such counties, in the case of primary elections, and the court of common pleas, in the case of general elections, shall appoint one of the judges of election of such county, or part of such county comprised within such district, to take charge of the returns of all votes cast take charge of the returns of all votes cast at any primary or general election in said county, or part of said county, for any candidate or candidates for the nomination of Representatives in Congress from said district.

Section 4. Such return judges shall meet at such places in their respective districts as herein designated.

The return judges of the ninth district shall meet at the court house in Allentown, in the county of Lehigh.

The return judges of the tenth district shall meet at the court house in Lancaster, in the county of Lancaster.

The return judges of the thirteenth district shall meet at the court house in Pottsville, in the county of Schuylkill,

The return judges of the fifteenth district shall meet at the court house in Montrose, in the county of Susquehanna.

The return judges of the sixteenth district shall meet at the court house in Williamsport, in the county of Lycoming.

The return judges of the eighteenth district shall meet at the court house in Lewistown, in the county of Mifflin.

The return judges of the nineteenth district shall meet at the court house in Harrisburg, in the county of Dauphin.

The return judges of the twentieth district shall meet at the court house in Warren, in the county of Warren.

The return judges of the twenty-first district shall meet at the court house in Stroudsburg, in the county of Monroe.

The return judges of the twenty-second district shall meet at the court house in Gettysburg, in the county of Adams.

The return judges of the twenty-third district shall meet at the court house in Hollidaysburg, in the county of Blair.

The return judges of the twenty-fourth district shall meet at the court house in Uniontown, in the county of Fayette.

The return judges of the twenty-fifth district

shall meet at the court house in Washington, in the country of Washington.

The return judges of the twenty-sixth district shall meet at the court house in Beaver, in the country of Beaver. in the county of Beaver.

The return judges of the twenty-seventh dis-

trict shall meet at the court house in Brook-ville, in the county of Jefferson.

The return judges of the twenty-ninth dis-trict shall meet at the court house in Mead-

ville, in the county of Crawford.

Section 5. Such return judges shall meet and cast up the several returns of the counties, or parts of counties, composing the district on the Tuesday next following the day on which the official computation of the county

returns in all of such counties shall have been completed.

Section 6. The return judges shall execute, under their hands and seals, a general and true return of the whole district, which, in case such return is of the general election, shall be deposited with the prothonotary of the county wherein the return is executed, or, in case the return is of a primary election, with the county commissioners of such county. Immediately upon the receipt of such return, the prothonotary or county commissioners, as the case may be, shall make copies of such return, and shall transmit one copy thereof, properly certified, to the Secretary of the Commonwealth, and the other copy or copies, also certified, to the person or persons receiving the highest number of votes cast at the preceding general or primary election for the office for which the election was held or the nominations Section 6. The return judges shall execute, which the election was held or the nominations were made in the district.

Section 7. Every return judge shall receive, out of the treasury of his proper county, the sum of ten dollars for each day actually employed in computing such vote, and, in addi-tion thereto, shall receive ten cents for every mile necessarily traveled in going to and from the place of meeting. Section 8. The first election under this act

shall be held at the general election in the year one thousand nine hundred and thirty-two.

The members of Congress now in office shall continue in such office until the expiration of

their respective terms.

Vacancies now existing or happening after the passage of this act and before the commencement of the terms of the members elected at the election of one thousand nine hundred and thirty-two, shall be filled for the unexpired terms in the manner now provided by law in the particular district or at large, as the case may be.

Section 9. * * * All other acts and parts of acts inconsistent herewith are hereby repealed.
